## Required documents

If the application concerns the lifting of a driving ban issued to a driver of heavy vehicles (section 5 of this form), you must append the documents indicated below, issued by the Société de l'assurance automobile du Québec (www.saaq.gouv.gc.ca/en/reach-us). These documents must have been issued within the last 29 days:

- ✓ Monitoring of Heavy Vehicle Driver Conduct;
- ✓ Information Concerning the Driver's Record.

### **Fees**

The cost of processing an application are \$118 for each Registration identification number (RIN) and heavy vehicle driver indicated in section 3 of this form.
